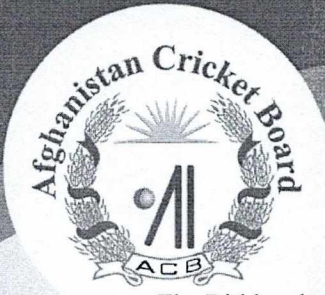

1. This Invitation for Bids follows the General Procurement Notice for this Project that appeared in Development Business published on 24/July/2019.
2. The Islamic Republic of Afghanistan Cricket Board has received a grant from the **International Cricket Council (ICC)** toward the cost of **Afghanistan Cricket Board (ACB)**, and it intends to apply part of the proceeds of this *grant* to payments under the Contract for **the Sub project packages/lots given in Para 3 below.**
3. **The Procurement Management Department**, acting on behalf of the Afghanistan Cricket board, now invites sealed bids from eligible and qualified bidders for the following package/lots, the Delivery with installation period is **48 days.**
4. Bidding will be conducted through the National Competitive Bidding (NCB) procedures specified in the ACB's Guidelines: Procurement under ICC Credits, and is open to all bidders from Eligible Source Countries as defined in the Bidding Documents.
5. 6. **Qualifications requirements include:**
 - Similar Contract for this project is not applicable.
 - The Bidder shall furnish documentary evidence that it meets the following financial requirement(s):
 - Bidders shall include a letter from a reputed bank indicating their financial status which will indicate their ability to perform the contract of the magnitude equivalent to the quoted price. Alternatively, the bidder may attach bank statement for the last six months which should have enough (equivalent to the price you are offering) credit balance to cover the quoted price.

- The Bidder shall furnish documentary evidence to demonstrate that it meets the following experience requirement(s):
- Bidders must provide evidence of having completed at least one verifiable contract of equal or larger magnitude in supply of similar procurement within the period of last five years as prime contract.
- For detailed post qualification verification please refer to Section I - Instructions to Bidders and Section II- Bid Data Sheet of the bidding documents.

A margin of preference for eligible national contractors/joint ventures shall not be applied.

7. A complete set of Bidding Documents in English may be obtain free of charge by interested bidders on the submission of a written Application to the address below.
8. The Bidding Documents shall be collected by the bidders from the address below.
9. The bidders or their authorized representatives are invited to attend a **pre-bid meeting which will take place on 7-Aug-2019, at 02:00 PM in the Procurement Management at the address given below** to explain the procedure of proper preparation and submission of bid, clarify issues and to answer questions on any matter that may be raised at that stage.
10. Bids must be delivered to the address below at or before 02:00 PM of 13-Aug-2019 **(if this date is announced an official holiday, then bids must be submitted next working day at the same time and venue)**. Electronic bidding shall not be permitted. Late bids will be rejected. Bids will be opened physically in the presence of the bidders' representatives who choose to attend in person at the address below at 02:00 PM of 13-Aug-2019.
11. All bids shall be accompanied by a "Bid Security" of amount 25000 Afghanis.
